The undersigned hereby assigns to the DGUF and Heidelberg University Library the right to additionally reproduce the contribution submitted by him/her for the purpose of publication in "Archaeological Information", following its formal acceptance, as an online document on their own servers, including the descriptive data (metadata) compiled in this connection, and to store the same permanently in electronic form and to make it publicly accessible in international data networks.

The DGUF and Heidelberg University Library shall be entitled to pass on the above-mentioned work to further nationally networked, long-term archiving systems, such as the German National Library in Frankfurt am Main, and to permit these bodies the use as specified above, for example. Further, the undersigned assigns to the DGUF and Heidelberg University Library the right to make technical changes to the work for the purpose of long-term archiving, subject to maintaining its integrity in terms of contents.

The undersigned author is responsible for the contents of his/her published work. The undersigned gives an assurance that he/she alone is entitled to grant rights of use in respect of the work under copyright provisions. The exploitation rights of the work in any other form remain unaffected hereby.

The author gives a further assurance that no statutory provisions or rights of third parties are infringed through any such publication (e.g. image rights, plagiarism). The DGUF and Heidelberg University Library shall be entitled to block the online access to the work, either in whole or in part, where there are specific indications that the work infringes statutory provisions, or that rights of third parties are being asserted which are not manifestly unsubstantiated. The blocking of access is to be limited to the period of time necessary for the conclusive clarification of the alleged infringement.

The undersigned author undertakes to indemnify the DGUF and Heidelberg University Library from all claims of third parties based on any claim for which he/she is responsible, and also to reimburse all costs arising by reason of a claim against them for which he/she is responsible. The DGUF and Heidelberg University Library do not pursue any commercial interests with the publication of the work. The DGUF and Heidelberg University Library provide this additional service free of charge for the authors; the undersigned will receive no remuneration from Heidelberg University Library.
